## **NOTICE OF ROAD/SIDEWALK WORK ACTIVITIES:**

May 4, 2016

Where: **East Main Street**, north side between Court St and Tanner St. Repair the existing brick sidewalk.

**Summer Street**, south side between Whites Mill Rd and Senior Dr. Add new sidewalk to the existing sidewalk on Senior Dr.

**Bradley Street**, north side between Hayter St. and Floyd St. Repair existing sidewalk along Bradley St. to

**Hayter Street**, west side between Bradley St and Elm St. Repair/replace the existing brick curb and gutter.

When: Beginning the **week of May 9, 2016**, and ending the **week of June 17, 2016**, weather permitting.

Crews will be replacing/repairing sidewalk, curb and gutter in the listed locations in town. This work will possibly require temporary lane closures; therefore, traffic will be directed through the work zone by flaggers. Traffic delays should be anticipated during this time. The use of alternate routes is recommended.
