Department News:

For the department, May marks the traditional beginning of tourist season. While we have visitors year round, May always brings more tourist opportunities through Thursday Jams and Plumb Alley Day. May also usually provides our first glimpse of summer temperatures, and this year was not an exception.

For the month of May the department responded to 345 calls for service. We were able to close all but 25 of those calls. This gave us an overall clearance rate of 92.7 percent for the month. The department responded to 47 IBR reportable cases in the month of May; at the conclusion of the month, 21 remained active. This gave us a clearance rate of 55.3 percent for all IBR offenses during the month of May.

In addition to normal patrol functions, the agency participated in several events throughout the month. Some of the highlights include:

- May 10th- Girl Scout Troop 124 visited the PD. Officer
 Richardson and Wilmoth spent the evening with the girls
 from the troop fielding questions about equipment, vehicles,
 finger printing, and how they became interested in law
 enforcement.
- May 13th- Our very own Officer Aaron Hagy graduated from the police academy. With five months of basic training complete, he now enters the field training phase of his career. Before graduation, the class dedicated a new flag pole on the police academy grounds to display the blue line flag to commemorate the lives of officers killed in the line of duty. We were honored to have our Town Manger, Mr. Kelly, and our Assistant Town Manager, Ms. Rosenbaum attend both ceremonies.



- May 15th-21st- National Police Week was a tremendous success. Ms. Montgomery and Ms.
 Knight arranged several treats for the officers during this week. There was also a big push to
 have businesses and individuals wear blue on Friday the 20th in support of law enforcement.
 Many of those wearing blue sent photographs to the police department to show their support.
- May 17th- We conducted our first "Tweet Along" with an officer. Officer Wilmoth agreed to share her patrol experiences with followers on the police department's twitter page.
 Throughout the day, followers learned some of the routine, and not so routine, duties that an officer performs.
- May 19th- By request of some of our followers, another Tweet Along was conducted with Sgt. Duncan. Several inquiries were received concerning the differences in duties between a Patrol Officer and a Patrol Sergeant. Sgt. Duncan was kind enough to share his experiences during a typical shift.
- May 22nd- The Woodland Hills Christian Church held an Officer
 Appreciation Service to recognize the efforts of officers locally. They
 also presented those in attendance with a special challenge coin to
 commemorate the event.
- May 27th- In one of the more unusual calls for the month,
 Officer Lucy was dispatched to a local business on Main Street
 in reference to a snake that was over the entry door. Upon
 arrival, Officer Lucy and a brave citizen, removed the black
 snake from above the doorway and relocated it to an open
 grassy area.
- May 28th- We had a hot and busy Plumb Alley Day. Officers stayed active walking the alley, assisting with traffic movements, recovering lost articles, and interacting with those in attendance. This is consistently one of best attended events in the town.
- May 31st- Officers Brummitt and Lucy conducted a presentation for a local Boy Scout Troop.
 Topics such as cyber bullying, police equipment, and law enforcement as a career were discussed with the troop.

During the month of May the police department spent <u>64.5 hours</u> either waiting in the ER with an ECO patient or in transport of a TDO patient. This came at a <u>direct, unsubsidized, cost to</u> <u>the tax payers of \$1,940.85</u> for the month. This equates to \$242.61 per mental health event during the month of May.

Enforcement News:

The department conducted DMV overtime enforcement during the month of May. Six (6) officers worked an additional 66.5 hours of enforcement on eleven (11) different dates. Enforcement focused on high crash areas, and the work zone on Jonesboro Road. These officers conducted forty-six (46) traffic stops, issuing thirteen (13) warnings and thirty-four (34) citations. Twenty-nine (29) of the citations were for excessive speed and five (5) were for other traffic infractions. The agency expended \$1,737.96 in overtime enforcement this month, which are reimbursed by Virginia Department of Motor Vehicles.


