During the month of April the police department spent <u>51.5 hours</u> either waiting in the ER with ECO patients or in transport of TDO patients. This came at a <u>direct, unsubsidized, cost to the tax payers of \$1,939.14</u> for the month. This equates to \$215.46 per mental health event during the month of April.

In order to have an understanding of mental health cases affect the department and the taxpayers, I have developed the following chart to track the hours and total cost associated with mental health cases each month:

School Resource Officers Report - April

Disciplinary Referrals:

During the month of April the School Resource Officers had several incidents that involved counseling of students for situations that were not criminal in nature but could evolve to be. With the officers taking proactive steps ahead of time, the issues are usually resolved before they turn criminal and require police or court intervention. Some of these incidents include:

Abingdon High School:

• Traffic Crash - Private Property

E.B Stanley Middle School:

- Paper Service
- Simple Assault
- Welfare check (2)

During the month of April the following non-reportable incidents either occurred at Abingdon High school and EB Stanley Middle school:

- SRO Hay assisted the Investigations Section with an active investigation.
- On April 12th, EB Stanley Middle school hosted a law enforcement luncheon that hosted the areas local law enforcement. This event was coordinated through Mrs. Courtney Turman, a 7th grade teacher, to show appreciation law enforcement in our area. A BBQ lunch was provided to show the schools appreciation.
- On April 24, SRO Heath took part in a research project being done by Virginia Tech on various
 pathways that can lead students into the prison pipeline in Virginia. Officer Heath was interviewed
 because of the work that is being done at E.B Stanley Middle School for keeping students in
 classrooms and not court rooms. Assistant Professor Kazi Patrizio of Virginia Tech's Educational
 leadership program advised E.B Stanley as being identified as being one of the ten most exemplar
 schools in Virginia.
- Daily checks of doors and outside premises are performed at each school on a regular basis as well to ensure the security and safety of staff and students in the buildings.

Calls for Service:

For the month of April the department responded to 345 calls for service. We were able to close all but 19 of those calls. This gave us an overall clearance rate of 94.4 percent for the month. The department responded to 29 IBR reportable cases in the month of March; at the conclusion of the month, 15 remained active. This resulted in a clearance rate of 48.2 percent for all IBR offenses during the month of April.

Traffic Enforcement News:

The department conducted DMV overtime enforcement on six dates during the month of April. Four officers worked an additional 39.75 hours of overtime resulting in thirty-eight (38) traffic stops, which yielded 28 summons and 11 warnings. Twenty-three (23) citations were for speed violations, two (2) were for inspection or registration violations, and three (3) were for other traffic violations. This came at a cost of \$991.48, which is reimbursed through the grant.
