Department News:

May is a special month for police across the country. In addition to the regular duties of the police, May is special because of National Police Week. On October 1, 1962, President John F. Kennedy signed Public Law 87-726, declaring May 15 as National Peace Officers Memorial Day and the calendar week in which May 15 falls as National Police Week, the annual tribute to law enforcement service and sacrifice. The Violent Crime Control and Law Enforcement Act of 1994 amended the law, and Public Law 103-322 was signed by President Bill Clinton, directing that the U.S. flag be displayed at half-staff on all government buildings on May 15 each year.

Locally, we use this as a time of community engagement to encourage people to wear blue in support of law enforcement. Many in our community wore blue, tied blue ribbons on lamp posts and columns, or changed their porch lights to blue bulbs for the week. It is a great feeling to see the support of the community.

In May we also had several other reasons to celebrate:

- May 1st: We hosted a Flash Blood Drive in honor of retired Sgt. Danny Freeman. Sgt. Freeman has been undergoing treatment at Vanderbilt Medical Center and Blood Assurance was looking for a place to hold a blood drive. We worked together to provide an opportunity for people to give blood locally, in honor of Sgt. Freeman. Unfortunately, the weather was not at all cooperative, but we were still able to end the day with several donors.
- May 8th: the College of Older Adults visited the PD and were given the opportunity to explore the technology packed inside our patrol cars with Lt. Holbrook. Once again, the weather made the event memorable in the form of a cold, windy, May morning.



May 15th-21st: We observed National Police Week. Many in our community
provided snacks, cards, and other signs of appreciation for the staff. A special thank you goes

During the month of May the police department spent <u>20.5 hours</u> either waiting in the ER with ECO patients or in transport of TDO patients. This came at a <u>direct, unsubsidized, cost to the</u> <u>tax payers of \$529.23</u> for the month. This equates to \$105.85 per mental health event during the month of May.

School Resource Officers Report - May

Disciplinary Referrals:

As a part of their normal activity, daily checks of doors and outside premises are performed at each school to ensure the security and safety of staff and students in the buildings.

During the month of May the School Resource Officers had several incidents that involved counseling of students for situations that were not criminal in nature but could evolve to be. By taking proactive steps ahead of time, the issues are usually resolved before they turn criminal and require police or court intervention. Some of these incidents include:

Abingdon High School:

On May 11th SRO Heath assisted with E.B Stanley's 8th Grade graduation that was held at Abingdon High school's auditorium. The Program lasted approximately two hours and was followed by the 8th grade dance at the middle school.

As the school year ends Officer Heath will be returning to the police department to assist with patrol and Investigations.

The new school year will begin on August 9th.

Calls for Service:

For the month of May the department responded to 350 calls for service. We were able to close all but 19 of those calls. This gave us an overall clearance rate of 94.5 percent for the month. The department responded to 42 IBR reportable cases in the month of May; at the conclusion of the month, 16 remained active. This resulted in a clearance rate of 61.9 percent for all IBR offenses during the month of May.

Traffic Enforcement News:

The department conducted DMV overtime enforcement on six dates during the month of May. Four officers worked an additional 17.5 hours of overtime resulting in twenty-two (22) traffic stops, which yielded 15 summons and 11 warnings. Twelve (12) citations were for speed violations, and the others were for a seat belt violation, failure to stop for police, an no inspection. This came at a cost of \$440.40, which is reimbursed through the grant.








Citations By Officer - Officer Initiated May 2017
