As we prepare for event season, we have to maximize our training opportunities for officers who will need certification hours. We have expanded our use of online training to allow officers to train at their own pace while still keeping them on the work schedule. This month the entire department completed on online class in Diplomatic Immunity. In addition, four members completed a sixteen hour training class on Constitutional Foundations for Law Enforcement. The entire department will be completing this class in the coming months.

Our BIG event for the month was participating in the Career Fair at Abingdon High School on February 20th. The career fair is for Juniors and Seniors and takes place during the lunch block. During the month of February the police department spent <u>39 hours</u> either waiting in the ER with ECO patients or in transport of TDO patients. This came at a <u>direct, unsubsidized, cost to the tax payers of</u> <u>\$ 962.13</u> for the month. This equates to \$192.43 per mental health event during the month of February. Officers from the department traveled 634 miles across the Commonwealth in transport of mental health cases during the month.

In order to have an understanding of how mental health cases affect the department and the taxpayers, I have developed the following chart to track the hours and total cost associated with mental health cases each month:

School Resource Officer Report

During the month of January, the following reportable offenses occurred in our schools:

Abingdon High School Underage possession of Tobacco - 4 Assault - 2 Miscellaneous Call - 3 Traffic Crash - 2 E.B. Stanley Middle School Miscellaneous Call - 5 Welfare Check - 1 Underage possession of Tobacco - 1 DSS Referral - 1

During the month of February the following non-reportable incidents occurred at Abingdon High school or E.B. Stanley Middle school.

February 12th: Officer DeBusk assisted Dr.Davis with two home visits due to truancy issues.

February 13th: Officer DeBusk diffused a verbal argument between two female students by intervening before it escalated to an assault.

Officer Heath was advised by a staff member of Highlands Community Services that a female student at E.B. Stanley was refusing to go home with her case worker and was asked if he could speak to her. Upon meeting with the student and the principal the situation deescalated and the student decided to go with the in home worker.

Officer Heath was advised of a student who had misplaced her cell phone. After contact with the student's parent, the student discovered the cell phone in her locker. The parent advised that they had not wanted any type of official report.

- February 16th: Officer DeBusk observed a verbal argument between two male students in the hallway of Abingdon High school. He was able to speak to the students and intervene before it escalated to an assault.
- February 27th: Officer Heath spoke with two 7th grade students about inappropriate comments through facebook messenger that escalated in to a verbal disagreement at school. Both students were advised of potential consequences that could result from sending messages of this type. The students agreed to work out their differences and possibly become friends again.

Daily checks of doors and outside premises are performed at each school on a regular basis as well to ensure the security and safety of staff and students in the buildings.

Calls for Service:

During the month of February the department responded to 311 calls for service. We were able to close all but 13 of those calls. This gave us an overall clearance rate of 95.8 percent for the month. The department responded to 35 IBR reportable cases in the month of February; at the conclusion of the month, 12 remained active. This resulted in a clearance rate of 65.7 percent for all IBR offenses during the month of February.

Traffic Enforcement News:

The department conducted DMV overtime enforcement on six dates during the month of February. Five officers worked an additional 46 hours of overtime resulting in sixty-one (61) traffic stops, which yielded 36 summons and 26 warnings. Twenty-seven (27) citations were for speed violations, six (6) were for inspection violations, and one (1) violation was for a Registration Infraction. In addition to the traffic citations, officers also made two arrests as a result of the additional enforcement. This came at a cost of \$1,050.60, which is reimbursed through the grant.

As always, I am eager to address any questions or concerns you may have concerning the operations of the police department.




