(3) Case No. 372 - Abingdon First Church of God, (Cameron L. Wolfe, Jr., AIA, Representative), 504 Whites Mill Road, Abingdon, Virginia 24210; application for a variance from the requirements of Article 6, Section 6-4-1, Setback Regulations, in the R-3 Residential Zoning District, contained in the Zoning Ordinance. Tax Map No. 2 (3) 4.

This application was submitted as the result of a proposed new addition to existing structure located at 504 Whites Mill Road.

The date of the application is February 27, 2002.

The approximate cost of proposed structure is \$500,000.00.

The ordinance limitation in Article 6, Section 6-4-1, Setback Regulations, in the R-3 Residential Zoning District requires 55 ft. from center; amount requested by each applicant is 45 ft.*; a variance request of 10 ft. or 18%. *Width of right of way for Whites Mill Road is 30 ft. total. Half of that width from center-line to property line is 15 ft. The church wishes to construct addition to existing building 30 ft. from property lines, which is 45 ft. from center line of Whites Mill Road.

All adjoining and adjacent property owners were notified of this hearing.

Mr. Henninger stated that he felt other options had been investigated, however, none of the other options were feasible, therefore, he could not be opposed to the request.

After discussion, Mr. Stevens made a motion that the variance request, in the amount of 10 ft. be approved in Case No. 372. Mrs. Henderson seconded the motion, with unanimous approval.
