(3) Case No. 369 - BB&T Bank/Harlan Laws Corporation (Jeremy)Galloway, Representative), 304 Muldee Street, Drawer 15070, Durham, NC 27704; application for a variance from the requirements of Article 21, B-2 General Business District, Section 21-2,b, Freestanding Signs, in the B-2 Zoning District, contained in the Zoning Ordinance. Tax Map No. 17 (17) 8.

This application was submitted as the result of a proposed new structure to be located at 233 Wyndale Road and, therefore, a request for a variance from Article 21, <u>B-2 General Business</u> <u>District</u>, Section 21-2-2,b <u>Freestanding Signs</u>, in the B-2 Zoning District, contained in the Zoning Ordinance.

Date of application is July 19, 2001, requesting a Regular Meeting scheduled for this date, August 14, 2001.

The referenced property is located at 233 Wyndale Road.

The approximate cost of the proposed development (signs) is \$14,000.00.

The explanation of this request is to allow new structure to have the following signage installed:

- 1. two (2) 4' x 8' double faced internally illuminated pole signs reading: "BB&T 24 Hour Banking" with a 10' x 16" pole cover. Each sign will stand 14' 1" tall; one sign to be installed on Wyndale Road and one sign to be installed on Village Boulevard.
- 2. two (2) 10" x 30" directional signs, non-illuminated, standing 2' 8 " tall.
- 3. one (1) 24" set of fabricated BB&T non-lighted letters with white faces, to be installed onto brick fascia.

The ordinance limitation in Article 21, Section 21-2-2,b in the B-2 General Business District allows one (1) sign; amount requested by applicant is two (2); a variance request of one (1) or 100%.

All adjoining and adjacent property owners were notified of this hearing.

After discussion, Mr. Connett made a motion that the variance request in Case No. 369 be granted, due to terrain conditions, which causes a lack of visibility. Mr. Shuman seconded the motion, with unanimous approval.
