(4) **Appeal No. 99-001**

Appellant: Allen Stigall/Bob's Muffler Shop, 423 Kendrich Hollow Road, Bristol, Tennessee 37620

Code Section: BOCA, Section 705.2 1996 Edition References: BOCA Commentary/Attached Request

Question/Appeal:

BOCA, 1996 Edition, Section 705.2 and corresponding table, requires Use Group (B) Business, with exterior walls within five (5) feet of a property line, to have the fire resistance rating of 2 hours. Due to possible hardship of applying a 2-hour resistant rating to 5B, wood frame and metal construction, would a modification of this section be appropriate?

Mr. Stigall stated the proposed addition would be situated within 1 foot of the property line. The construction process of metal clad building, as stated in attached letter, posed a harship when applying a 2-hour rated assembly.

Mr. McKinney stated that moisture resistant gypsum can be used and suggested that Mr. Stigall study options available in applying a 2-hour rated assembly. Mr. McKinney also made the appellant aware that a U.L. design must be submitted to the Building Official.

A motion was made by Mr. McKinney that a modification was not in order and should not be granted. Mr. Ashley seconded the motion, with unanimous approval.

The contractor is to pursue the application of a 2-hour assembly or move the proposed addition, greater than 5 feet from the property line and comply with applicable codes.

There being no further business, the meeting was adjourned.
