



**A RESOLUTION OF THE COUNCIL FOR THE TOWN OF ABINGDON, VIRGINIA IN
SUPPORT OF APPLICATIONS TO THE VIRGINIA DEPARTMENT OF
TRANSPORTATION HIGHWAY SAFETY IMPROVEMENT PROGRAM AND
PEDESTRIAN SAFETY ACTION PLAN PROJECTS**

WHEREAS, the Town of Abingdon desires to submit an application for allocation of funds provided by VDOT for the projects listed below, and no local match will be required by the Town.

BE IT RESOLVED by the Council of the Town of Abingdon as follows:

1. The Town Council hereby supports the application referred to herein and hereby authorize the Town Manager to submit such application to VDOT for funds from VDOT's Highway Safety Improvement Program for VDOT's six (6) year plan and Pedestrian Safety Action Plan for the FY 2019 for the following projects.

a. The first project includes installing sidewalk and related appurtenances along Clark Street from Whites Mill Road to Court Street.

b. The second project includes installing sidewalk to connect existing sections of sidewalks along East Main Street between Rugby Terrace and Hutton Street, along the North-side of East Main Street.

c. The third project includes pedestrian improvements along West Main Street from Patton Street to Holston Street, along the North-side of West Main Street.

d. The fourth project includes pedestrian improvements along Preston Street from West Main Street along the East-side to connect to the Urban Trail.

e. The fifth project includes a Pedestrian Safety Action Plan on Russell Road to install a high-visibility crosswalk connecting the now existing parking lot to the fields used by the Little League.

2. The Town Manager is further authorized to take such further actions and execute such further documents, as may be necessary to submit the above application and to furnish such additional information as may be required for such application.
