



**A RESOLUTION OF THE COUNCIL FOR THE TOWN OF ABINGDON, VIRGINIA IN
SUPPORT OF HEALTH INSURANCE CREDIT PROGRAM FOR LOCAL
GOVERNMENT EMPLOYEES**

WHEREAS, the Town of Abingdon desires to provide health insurance credits to eligible current and future retirees as defined in Code of Virginia, 1950, as amended, Article 5, Chapter 1 of Title 15.1.

BE IT RESOLVED by the Council of the Town of Abingdon that the Town of Abingdon (55300) does hereby elect to provide the Health Insurance Credit Program as provided in the Code of Virginia Section 51.1-1402 for its eligible current and future retirees as defined in Article 5, Chapter 1 of Title 51.1 of the Code of Virginia.

BE IT ALSO RESOLVED that the Town of Abingdon agrees to accept all liability for any current or future additional employer contributions and any increases in current or future employer contribution rates resulting from its election to provide the benefits of the Program to its retirees.

BE IT FURTHER RESOLVED that the Town of Abingdon elects to allow its eligible retirees to receive the benefits under the Program effective November 1, 2018.

NOW THEREFORE Wayne Craig, Mayor and Kimberly Kingsley, Clerk, are hereby authorized and directed in the name of the Town of Abingdon to execute any required contract in order that said eligible retirees of the Town of Abingdon may participate in the Health Insurance Credit Program as provided for in the Code of Virginia. In execution of any contract, which may be required, the seal of the Town of Abingdon shall be affixed and attested by the Clerk, and said officers of the Town of Abingdon are authorized and directed to pay over to the Treasurer of Virginia from time to time such sums as are due to be paid by the Town of Abingdon for this purpose.
