

**AN ORDINANCE OF THE COUNCIL OF THE TOWN OF ABINGDON, VIRGINIA
PROPOSING AN AMENDED BUDGET FOR THE TOWN OF ABINGDON,
VIRGINIA AND TO MAKE APPROPRIATION FOR THE AMENDMENT OF
CURRENT EXPENSES AND REVENUES OF THE TOWN AND
FOR THE FISCAL YEAR BEGINNING JULY 1, 2018 AND ENDING JUNE 30, 2019**

WHEREAS, a proposed amended balanced budget setting forth the revenues and expenditures for the Town of Abingdon, Virginia was prepared and submitted to the Abingdon Town Council on November 5, 2018; and

WHEREAS, a public hearing was held on November 5, 2018 in accordance with Sections 15.2-2504; 15.2-2507 and 15.2-1427 of the Code of Virginia, 1950, as amended, concerning amendment of the 2018/2019 Town of Abingdon, Virginia Fiscal Year budget as further set forth herein; and

WHEREAS, the first reading of the amended ordinance was held by the Council of the Town of Abingdon, Virginia on November 5, 2018; and

WHEREAS, the following amendment proposed for the 2018-2019 fiscal year amended budget:

Include a federal grant awarded, with a match from Washington County, Virginia, for the purchase of air packs to be split between the Town of Abingdon and other Washington County participating fire departments. The total budget amendment will increase the budgeted expenditures and offsetting revenues by \$856,800 (Assistance to Fire Fighter Grant, Department of Homeland Security, Federal Emergency Management Agency in the amount of \$778,910 and \$77,890.00 from Washington County, Virginia)

NOW THEREFORE, BE IT ORDAINED, by the Council of the Town of Abingdon, Virginia, pursuant to Section 15.2-2500, et seq. of the *Code of Virginia*, 1950, as amended, the following:

Revenue General Fund be increased by:

Revenue-Other Agencies an additional \$856,800

Expenses General Fund be increased by:

Expenses Public Safety: Fire Department an additional \$856,800

BE IT FURTHER ORDAINED that this Ordinance of adoption of the amended budget shall take effect on November 5, 2018.




