- G. POSSIBLE CLOSED SESSION WITH MEMBERS OF THE ECONOMIC DEVELOPMENT AUTHORITY AND COMMUNITY DEVELOPMENT COORDINATOR PURSUANT TO §2.2-3711(A)(39) OF THE CODE OF VIRGINIA, AS AMENDED, FOR THE PURPOSE OF DISCUSSION OR CONSIDERATION OF INFORMATION SUBJECT TO THE EXCLUSION IN §2.2-3705.6 RELATED TO ECONOMIC DEVELOPMENT. Mr. Shuman stated that the presentation should be in open session. Kenny Shuman, Chairman of the Economic Development Authority, presented to Council a summary report of interviews with locally owned or managed businesses to determine the plans for the future Economic Development Authority's actions or recommendations. Mr. Shuman presented five common themes from their interviews as follows:

- It is very difficult to work with the town to start a business or modify an existing structure;
- This being the first time anyone has ever reached out to solicit thoughts on economic development;
- The town has been complacent in terms of efforts for economic development; the town has rested on its reputation for too long;
- The restrictive nature of the Historic Properties Review Board has discouraged investment in the historic district while at the same time there are properties out of compliance with the requirements. This area along with the first point drew the most ire of the respondents; and
- It is hard to locate information on rental housing.

Mr. Shuman also presented the Authority's recommendations as follows:

- Better communication of what is expected, in terms of rules and requirements and what businesses need to open;
- · Consider offering incentives for businesses;
- Don't be afraid to say, "we want your business here and we are going to help you.";
- Consider maximizing use of Barter Green to establish a bustling Town Square atmosphere;
- Continue to offer façade improvement opportunities in partnership with business owners and/or building owners to improve aesthetics that will attract additional customers as well as additional businesses;
- Work with banks or other financial institutions to identify sources for capital for prospective businesses or business expansions;
- Involve local businesses, commercial real estate owners, potential businesses, commercial lenders and investors in a cooperative atmosphere to foster new growth.
- Recommend a review of the Historic Preservation Review Board guidelines to make more clear, realistic and promote growth in the historic district; and
- Update website.

Discussion ensued. Mayor Craig questioned if a member of the EDA would be interested in serving on a committee to discuss updating ordinances. Mr. Bradley thanked the EDA for their work.

Stacey Reichler, Director of Human Resources and Chuck Banner, Director of Finance/Treasurer presented information to Council regarding the retiree health care stipend where the Town currently pays \$120 per quarter for thirty-nine (39) retirees. Stacey Reichler stated that because of the liability of the retiree stipend the auditors presented two solutions and recommend that the Council consider a resolution for Virginia Retirement Services to manage the retiree program.
