- (3) Certificate of Appropriateness – **Shortridge and Shortridge, P.C. (Michael and Judy Shortridge)**, 170 West Valley Street, Abingdon, Virginia 24210, application for Certificate of Appropriateness for approval of sign to be located at **170 West Valley Street. Tax Map No. 12 (1) 62.**

This is a request for approval of one (1) sign to be located at 170 West Valley Street.

The sign will be 24” x 24” in size, with Parachute Blue (#795B) background, white lettering, and will read “SHORTRIDGE AND SHORTRIDGE, PC, ATTORNEYS AT LAW”. The sign will be located at back of sidewalk and suspended from post 4.5 ft. to 5 ft. in height.

Due to the brightness of the color of Parachute Blue (#795B), Mrs. Humphreys suggested that the color be changed to Howard Blue (#797B).

After discussion, Mrs. Humphreys made a motion that the application be approved, subject to the color being changed from Parachute Blue (#795B) to Howard Blue (#797B). Mr. St. John seconded the motion, with unanimous approval.

This is a request for approval of parking area to be located at the rear of 152 West Valley Street.

The parking area will accommodate five (5) vehicles and be composed of designer gravel with trim and landscaping. The driveway will be used as access to parking area.

The proposed redwood sign will be 24 in x 24 in. in size, with cream color background, black lettering and will be mounted on two wooden posts. The sign will read “BROWNING AND LAMIE, P.C.”
