- (2) Certificate of Appropriateness – **Helen and Klell Napps**, 155 East Main Street, Abingdon, Virginia 24210; application for Certificate of Appropriateness for approval to change previously approved roof color from black standing seam to charcoal gray standing seam, for structure located at **155 East Main Street. Tax Map No. 13 (1) 55.**

Howard, Representative**, 266 West Valley Street, Abingdon, Virginia 24210; application for Certificate of appropriateness for approval of two (2) signs to be located at **266 West Valley Street. Tax Map 11 (1) 93.**

This is a request for approval of two (2) signs to be located at 266 West Valley Street.

One (1) sign, sandblasted material, will be 16 in. x 36 in. in size, cream colored background with green lettering and trim, and will be mounted on a 4 in. x 4 in. salt-treated post. The sign will be displayed by a metal bar, painted dark brown, being 5 ft. in height.

One (1) sign, sandblasted material, will be 8 in. x 27 in. in size, cream colored background with green lettering and trim, and will be mounted on a 4 in. x 4 in. salt-treated post with cut decoration at top. The post will be the same color of green as lettering and trim.
