E. UPDATES FROM STAFF AND PLANNING COMMISSION MEMBERS

SIGN ORDINANCE

Mr. Shuman read the following sign ordinance into the record:

Discussion of the proposed amendment to Article 21.-Signs, Section 21-8.-Prohibited signs. (t). Vehicles and trailers shall not be used primarily as static displays, advertising a product or service, nor utilized as storage, shelter or distribution points for commercial products or services for the general public.

Mr. Boswell told the commission that at the October 28, 2019 meeting Town staff was asked to review the existing sign ordinance and to make suggestions for changes to the ordinance. The ordinance with the changes was reviewed by the Town Attorney and was deemed as an obtainable and enforceable ordinance.

Mr. Sproles asked if the issues presently before the board would be enforceable with the new ordinance, Mr. Boswell assured the board that the Town Attorney feels this will make the issues enforceable.

Mr. Bradley suggested that the ordinance read as follows:

Discussion of the proposed amendment to Article 21.-Signs, Section 21-8.-Prohibited signs. (t). Vehicles and trailers shall not be used-primarily as static displays, advertising a business product or service, nor utilized as storage, shelter or distribution points for commercial products or services for the general public.

Mr. Boswell stated that he and the Town attorney have discussed leaving primarily in the ordinance so that a business that has a moving sign by day, which is stationary at night may be allowed to be parked.

Mr. Boswell informed the board that if this ordinance is passed at tonight's meeting that it would then be presented on February 24, 2020, Planning Commission as a Public Hearing. After the Public Hearing, the ordinance would then go back before the Town Council for a final vote.

On a motion by Mr. Bradley, to have Town staff proceed with advertising the Public Hearing for the February 24, 2020, Planning Commission meeting, seconded by Mr. Anderson the Planning Commission approved the motion.
