1. Proposed zoning text amendment to Article 9. OI Office and Institutional District, Section 9-2.-Same-Special uses, to allow two-family and multi-family dwellings as a special use.

2. Proposed zoning text amendment to Article 10,-B-1 Limited Business District, Section 10-2,-Same-special uses, Article 11.-B-2 General Business District, Section 11-2.-Same-Special uses, and Article 12.-B-3 Central Business District, Section 12-2.- Same-Special uses, to allow short-term rentals as a special use.

Mr. Shuman asks if the definition of this proposal would solve the previous issue of short-term rentals.

Mr. Boswell stated that by adopting the state code definition for short-term rental the Commission would resolve the current absence of a description.

The board unanimously approved the proposed text amendment to Article 10, for short-term rentals as a special use.

3. Proposed amendment to the Town of Abingdon Comprehensive Plan pursuant to Virginia Code Section § 15.2-2229.

Mr. Austin opened the Public Hearing.

Mr. Austin closed the Public Hearing.

Mr. Boswell let the board know that the Comprehensive Plan process started back in January, 2019. The proposed plan is an entire overhaul of the previous plan. The State code requires the Virginia Department of Transportation ("VDOT") to review the Comprehensive Plan and submit any comments and/or recommendations.

Mr. Boswell stated VDOT had several comments and changes to be implemented into the revised Comprehensive Plan. Items to be included are:

- Corridors of statewide significance
- Revised table of functional classifications: arterial, minor arterial, and collector roads
- Removal of purposed connection of Meade Meadows to Berry Creek Drive, per public response from survey
- Updated cost estimates of roundabouts at Thompson Drive, Cook Street extension and Interstate 81 frontage road
- Updated table for Six Year Improvement Program.
 Addition UPC 116171: Extended Acceleration Lane (\$1.6 Million)

Mr. Todd Gordon, Senior Planner with EPR, will incorporate the recommendations from VDOT into Comprehensive Plan.

Mr. Gordon expressed that the Town would do well to draw careful ties between future transportation projects, Tables on pages 32 and 33, and the needs identified in the State Transportation Plan, also known as the VTRANS Plan. VDOT has suggested that we add additional tables to recognize the needs for the referenced projects. These needs include increasing safety and decreasing congestion on major roads like Main Street, Cummings Street, and Old Jonesboro Road. Making connections concerning these needs will improve upcoming funding probabilities. Mr. Gordon suggested adding these tables.

Mr. Shuman told Mr. Gordon that he had submitted several comments and was pleased to see those incorporated into the revised Comprehensive Plan.

Mr. Boswell stated the Comprehensive Plan will include language regarding the Sports Complex.

On a motion by Mr. Anderson, seconded by Mr. Shuman, recommending that the proposed comprehensive plan amendment be accepted as amended per the Virginia Code Section § 15.2-2229.
