

## A RESOLUTION OF THE COUNCIL FOR THE TOWN OF ABINGDON SUPPORTING THE APPLICATION FOR TRANSPORTATION ALTERNATIVE SET-ASIDE FUNDS FOR THE BOONE STREET PEDESTRIAN IMPROVEMENTS PROJECT

Whereas, in accordance with the Commonwealth Transportation Board construction allocation procedures, it is necessary that a resolution be received from the sponsoring jurisdiction or agency requesting the Virginia Department of Transportation establish a Transportation Alternatives Set-Aside project to be administered by the Town of Abingdon.

*Now, therefore, be it resolved*, that the Town of Abingdon, requests the Commonwealth Transportation Board to establish a project for the Boone Street Pedestrian Improvements; and

**Be it further resolved**, that the Town of Abingdon hereby commits to provide a minimum 20-percent matching contribution for this project and any additional funds necessary to complete the project; and

Be it further resolved, that the Town of Abingdon hereby agrees to enter into a project administration agreement with the Virginia Department of Transportation and provide the necessary oversight to ensure the project is developed in accordance with all state and federal requirements for design, right of way acquisition, and construction of a federally funded transportation project; and

**Be it further resolved**, that the Town of Abingdon will be responsible for maintenance and operating costs of any improvement/facility constructed with Transportation Alternatives Set-Aside funds unless other arrangements have been made with the Department; and

Be it further resolved, that if the Town of Abingdon subsequently elects to cancel this project the Town of Abingdon hereby agrees to reimburse the Virginia Department of Transportation for the total amount of costs expended by the Department through the date the Department is notified of such cancellation. The Town of Abingdon also agrees to repay any funds previously reimbursed that are later deemed ineligible by the Federal Highway Administration; and

**Be it further resolved,** that the Council of the Town of Abingdon hereby grants authority James Morani, Town Manager to execute project agreements for any approved Transportation Alternatives Set-aside projects for Fiscal Year 2021-22.
