#### D. CERTIFICATE OF APPROPRIATENESS

1. Certificate of Appropriateness – Greeko's Grill & Café, 211 W. Main St.; owner. Application for Certificate of Appropriateness for signage. Located at 211 W. Main Street, Abingdon, VA 24210. Tax Map No. (012-1-71) (VIDEO 16:14 – 35:35)

Mrs. Rice gave the staff report for the request for signage as the applicant is expanding an existing business to an adjacent building.

Mr. Mustafa Ahmed represented the property located at 211 W. Main St. Mr. Ahmed new business will be housed on the first floor of the building. He is requesting a 12 x 1 sign. Mr. Ahmed sign design has changed with a new name chosen for the new business, Rendezvous Café.

The board decided to table this COA until the following items can be obtained by Mr. Ahmed.

- 1. Sign size, location, letter details, size color, font style, letter layout (one line or stacked)
- 2. Type of lighting for the sign.
- 2. Certificate of Appropriateness Abingdon Virginia Visitor's Center, Fields Penn, Abingdon, VA, 24210; Owner. Jerry's Signs & Awning Inc. Jessica Cooke; Representative. Application for Certificate of Appropriateness for signage. Located at 208 W. Main Street, Abingdon, VA 24210. Tax Map No. (012-1-125) (VIDEO 3:12 16:13)

Mrs. Rice gave the staff report for the request of two signs, one on Main St. and the second one at the corner of Remsburg and Cummings Street. The signs must be

freestanding or attached to the structure. Sign size should be appropriate to the building size. Guidelines allow 4 square feet; they are requesting a total of 6 square feet.

Ms. Jessica Cooke represented Jerry's Signs and Tonya Triplett represented the Abingdon Visitor's Center.

Mr. Cooke described the two proposed sign as a carved HDU signs, with black, gray and white, double sided, non-illuminated, with wolf sculpture mounted to the top on sign base. The existing posts will be used with the signs mounted 5 ft. above ground level, clearing the existing fence for visibility. Sign without wolf sculpture measures approximately 4 square feet.
