Tonya Triplett, Director of Economic Development and Tourism, advised Council the public hearing for information regarding the Virginia Department of Housing and Community Development provides funding for local governments to address critical community development needs. Mrs. Triplett stated approximately \$17,000,000 was available this budget year, and the Town will apply.

Mrs. Triplett provided the example of a \$400,000 grant that allowed the Town to distribute \$336,000 to small businesses to provide meals to Faith In Action during Covid-19. An additional \$40,000 was used for administration fees, and \$25,000 provided equipment to Faith In Action to carry on the services.

Counsel Cameron Bell stated that the public hearing was required to start the application process.
