



# Town of Abingdon Virginia Parks and Playgrounds

## Landon Boyd Linear Park—247 A Street



### **Amenities**

Picnic Shelter with concrete flooring, 1 set of swings, multi-unit play structure . Historical marker located in park. Hammock hangout location. No bathrooms facilities in this Park.

### **Directions**

From I-81 South, use exit 17, turn left onto Cummings Street, or from I-81 North, use Exit 17, turn right onto Cummings Street, THEN turn right onto Green Spring Road, THEN take the first right onto A Street SE.

## William “Bill” Eberhardt Youth Park— Located on Park Street



### **Amenities**

Picnic Shelter with gravel flooring, 2 sets of Swings, Slide and Balance Beam, Multi Unit Play Structure, Single Basketball Court, Master Gardener Flower Gardens. There is a small creek winding through the park. No bathrooms facilities in this Park.

### **Directions**

From I-81 North, use Exit 17, turn Left onto Cummings Street Or From I-81 South, use Exit 17, turn right onto Cummings Street, THEN proceed to Main Street (approximately ¾ of mile), turn right onto Main Street, at first light turn right onto Pecan Street towards the Creeper Trail, turn left onto Park Street, the park will be on your left.

## Kings Mountain School Park—101 Highland Street



### **Amenities**

Picnic Shelter with concrete flooring, Gazebo with benches, Sand Box, Double Swing Set, Slide and Balance Beam. This park is fenced. No bathrooms facilities in this Park. Historical marker located in park

### **Directions**

From I-81 North, use Exit 17, turn Left onto Cummings Street Or From I-81 South, use Exit 17, turn right onto Cummings Street, THEN proceed to Main Street (approximately ¾ of mile), turn right onto Main Street, at first light turn right onto Pecan Street towards the Creeper Trail, after crossing the railroad tracks, turn left onto “A” Street, take the first right onto Kings Mountain Dr, follow the road up the hill to Highlands Street and the park will be on your right.

## Munchkin Park—328 Clark Street



### **Amenities**

Picnic Shelter with concrete flooring, Spiral Slide, Swing Set, Climb On Train, Balance Beam, Youth Fitness Activity Center, Multi Unit Play Structure. This Park has a ¼ mile walking track around its perimeter. Bathrooms facilities in this Park.

### **Directions**

From I-81 North, use Exit 17, turn Left onto Cummings Street Or From I-81 South, use Exit 17, turn right onto Cummings Street, THEN proceed to Main Street (approximately ¾ of mile), cross over Main Street to the next signal light, turn right onto Valley Street, go approximately ½ mile and turn left onto White’s Mill Road, go approximately ½ mile, turn left onto Clark Street, the park is just ahead on the left.

## Wye Park— Creeper Trail Head

### **Amenities**

Picnic Shelter with concrete flooring, This Park is open area located on the Creeper Trail about 500 yards up the trail from the Steam Engine. There are no bathrooms facilities in this Park. Hammock Hangout location. Not accessible by vehicle.

### **Directions**

From I-81 North, use Exit 17, turn Left onto Cummings Street Or From I-81 South, use Exit 17, turn right onto Cummings Street, THEN proceed to Main Street (approximately ¾ of mile), turn right onto Main Street, at first light turn right onto Pecan Street towards the Creeper Trail, after crossing the railroad tracks pull into parking lot on right had side. Cross the road and follow the Creeper Trail until you reach the park on your left.

## Coomes Recreation Center Play Station—300 Stanley Street



### **Amenities**

Picnic Shelter with concrete flooring, variety of swings, tire swing, climbing wall, multiple slides, foot bridges. Playground designed for children 12 and younger. Located on the grounds of the Harry L. Coomes Recreation Center. Bathrooms available inside and outside the facility. No pets allowed on the grounds except in Dog Park.

### **Directions**

Located on the Grounds of the Harry L. Coomes Recreation Center. From I-81 North, use Exit 19, turn left onto Highway 11 towards Abingdon OR From I-81, use Exit 19, turn right onto Highway 11 towards Abingdon, THEN approximately 1.5 miles turn right at 2 signal light onto Thompson Drive, go through first light up the hill turn right onto Stanley Street, follow the road around and the Recreation Center will be on your right.

## Veterans Memorial Park— Located along Cummings Street



### **Amenities**

5 picnic shelters with concrete flooring, Swings, Slide, See Saw, Geo Domes, Multi Unit Play Structure, Ceremony Field. Nice grassy park to walk through to enjoy the tribute of flags representing the branches of military service, the World War II Monument, the Korean War Monument, the Vietnam War Monument, the Lt. Billy Webb Memorial Tribute and the Bronze Ribbon Memorial. No bathrooms facilities in this Park.

### **Directions**

From I-81 North, use Exit 17, turn Left onto Cummings Street Or From I-81 South, use Exit 17, turn right onto Cummings Street, at the first signal light turn left onto Towne Centre Drive, take the first right onto Billy Webb Drive, the park is at the top of the hill.

## Lois H. Humphreys Park on Main Street — Located across street from the US Post Office

### **Amenities**



There is a large gazebo in the park with benches and a swing. There are four picnic tables on concrete pads. There are several benches to sit and enjoy the beauty in the park. Playground area for the kids.

### **Directions**

From I-81 North, use Exit 17, turn Left onto Cummings Street Or From I-81 South, use Exit 17, turn right onto Cummings Street, THEN proceed to Main Street (approximately ¾ of mile), turn left onto Main Street, the park is just ahead on the right past the next signal light

## Alvarado Station and Park—21183 Alvarado Road



### **Amenities at Station**

Men's and Women's Restrooms, community meeting room, handicap parking and access to Virginia Creeper Trail. Picnic shelter and tables, grill and campfire ring. Covered picnic tables, benches, small-craft launching area and restricted camping by reservation.

### **Directions**

From Exit 19 take Hwy. 58 towards Damascus. Turn right onto Rte. 722 -- Osceola Road, Merge onto Rte. 710 -- Alvarado Road, Turn right onto parking lot at Station.

## Abingdon Market Pavilion—Located on Remsburg Drive



### **Amenities**

Abingdon Farmers Market meets on Tuesday afternoons and Saturday mornings April through October. The Market is open during the off season with special hours and days. The facility is available for rent for special events. Bathrooms are located in the immediate area.

### **Directions**

From I-81 North, use Exit 17, turn Left onto Cummings Street Or From I-81 South, use Exit 17, turn right onto Cummings Street, THEN proceed towards Main Street (approximately ¾ of mile), before you get to the signal light turn left onto Remsburg Drive, the facility is located on your left.

## Valley Street Mediation Labyrinth—250 E. Valley Street



### **Amenities**

Come and relax while you walk the inlayed stone labyrinth and take your mind away from your daily grind.

### **Directions**

Located at 250 E. Valley Street between Tanner Street and White’s Alley.

## Rav Pettv and Foster-DeBose Baseball Fields—431 Russell Road



### **Amenities**

Field use by reservation and permission through the Abingdon Parks and Recreation Office. 2 Regulation Little League Fields, Playground Equipment onsite, picnic tables and concession stand open during season, batting cages. Bathrooms located in the Concession Stand area.

### **Directions**

From I-81 North, use Exit 17, turn Left onto Cummings Street Or From I-81 South, use Exit 17, turn right onto Cummings Street, THEN proceed to Main Street (approximately ¾ of mile), turn left onto Main Street, at the second signal light turn right onto Russell Road, go through the first signal light and the fields will be just ahead on your left

## Latture Field—205 Latture Field Drive



### **Amenities**

Field use by reservation and permission through the Abingdon Parks and Recreation Office. Latture field is used for Abingdon Midget League Football, Abingdon Little/Senior League Baseball and Abingdon Parks and Recreation Softball. The field area is also used during the year for many special community events. Picnic Tables onsite. Bathrooms located in the Concession Stand area.

### **Directions**

From I-81 North, use Exit 17, turn Left onto Cummings Street Or From I-81 South, use Exit 17, turn right onto Cummings Street, THEN proceed to Main Street (approximately ¾ of mile), turn left onto Main Street, go through the second signal light, pull into the parking lot on your right beside the Abingdon Police Department, use sidewalks to enter the field area.

## Coomes Recreation Center Tennis Court—300 Stanley Street



### **Amenities**

4 Regulation Courts  
Lighted courts until 10:00 pm  
Bathrooms onsite, inside facility

### **Directions**

Located on the Grounds of the Harry L. Coomes Recreation Center. From I-81 North, use Exit 19, turn left onto Highway 11 towards Abingdon OR From I-81, use Exit 19, turn right onto Highway 11 towards Abingdon, THEN approximately 1.5 miles turn right at 2 signal light onto Thompson Drive, go through first light up the hill turn right onto Stanley Street, follow the road around and the Recreation Center will be on your right.

## N. Church Street Tennis Courts— On N. Church Street



### **Amenities:**

Parking beside courts  
Picnic Area  
Water fountain by courts  
Lighted courts until 10:00 pm  
No bathrooms at this site.

### **Directions**

From I-81 North, use Exit 17, turn Left onto Cummings Street Or From I-81 South, use Exit 17, turn right onto Cummings Street, THEN proceed to Main Street (approximately ¾ of mile), cross over Main Street to the next signal light, turn right onto Valley Street, go approximately ¼ mile and turn left onto North Church Street, the tennis courts are just ahead on the right.

## Rotary Skate Park—300 Stanley Street



### Amenities

The park has a variety of structure for skill development.  
No bathroom at park but located on the grounds of the Coomes Recreation Center.

### Directions

Located on the Grounds of the Harry L. Coomes Recreation Center. From I-81 North, use Exit 19, turn left onto Highway 11 towards Abingdon OR From I-81, use Exit 19, turn right onto Highway 11 towards Abingdon, THEN approximately 1.5 miles turn right at 2 signal light onto Thompson Drive, go through first light up the hill turn right onto Stanley Street, follow the road around to the entrance of the Coomes Recreation Center

## Abingdon Dog Park—300 Stanley Street



### Amenities:

On-site parking  
One-acre park with five-foot (5') fence surrounding perimeter of park  
Double-gated transition area Small dog run area, fenced  
Benches for dog owner(s)/ handler(s)  
Doggie waste supply stations  
Covered garbage/waste cans  
Water fountain onsite for dogs and owners

No bathroom at park but located on the grounds of the Coomes Recreation Center.

### Directions

Located on the Grounds of the Harry L. Coomes Recreation Center. From I-81 North, use Exit 19, turn left onto Highway 11 towards Abingdon OR From I-81, use Exit 19, turn right onto Highway 11 towards Abingdon, THEN approximately 1.5 miles turn right at 2 signal light onto Thompson Drive, go through first light up the hill turn right onto Stanley Street, follow the road around past the entrance to the Coomes Recreation Center to the bottom of the hill, turn right onto Walden Road, park is located 2/10th of mile on right.

- \* You Must Clean Up Pet Waste
- \* Please Be Considerate of other Park Visitors
- \* No Smoking

## Abingdon/Rotary Skateboard Park Rules and Regulations

SKATE AT YOUR OWN RISK

Hours of Operation – Dawn till Dusk

The Skateboard Park will operate under the following general guidelines:

### Children 12 and under MUST be accompanied by responsible guardian.

The park is open to school age children only when Washington County Schools are closed or not operating.

No one is permitted on the grounds or park from sunset to sunrise, or as posted for the skateboard park.

For their own protection, all skaters are required to wear, at minimum, a protective helmet and elbow pads.

Abingdon Parks and Recreation has full authority over the skateboard park.

All rules and regulations of the Town of Abingdon and the Department of Parks and Recreation are fully enforceable.

Any and all classes or instruction take a priority over individual instruction or use.  
Appropriate clothing must be worn at all times.

No abusive language, actions or bad conduct permitted at anytime.  
This includes recklessness and/or rowdy behavior.

No food, drinks, cans, bottles, or chewing gum allowed in the skating area.

Skaters are required to clean up trash and remove all items they bring to the facility; failure to comply will result in loss of privileges.

No radios, boom boxes, portable stereos or personal audio equipment permitted.

**ABSOLUTELY NO SKATEBOARDING OR ROLLER BLADING IS PERMITTED ELSEWHERE ON TOWN/GROUNDS OR PROPERTY EXCEPT FOR THE SKATEPARK AREA. BICYCLE RIDING IS NOT PERMITTED ON THE SKATE PARK PROPERTY.**

All skaters participate at their own risk regardless of age.

**ABSOLUTELY NO ALCOHOLIC BEVERAGES, TOBACCO PRODUCTS, DRUGS OR ILLEGAL SUBSTANCES ARE PERMITTED ON TOWN PROPERTY.**

## ABINGDON DOG PARK RULES AND REGULATIONS

### GENERAL:

Park hours: Dawn to Dusk

Dogs must be on leash when entering and exiting the park PROHIBITED: Glass containers, Food, Tobacco, and Alcohol PROHIBITED: Dog food or treats inside the fenced area NO bicycles, skateboards, rollerblades or strollers allowed in the park

Dogs are prohibited from the walking trail

Dogs/Animals are prohibited from being around the Play Station or the Facility Any/all dog bites or scratches must be reported to:

Washington Co. Animal Control immediately – Call (276) 676-6210

### DOGS:

All dogs must wear a collar bearing identification information, owners full name and contact information and current rabies tag

Dogs exhibiting aggressive behavior must be removed from the park immediately

Spike collars are prohibited from use in the park and must be removed before entering the park

Dogs must have current vaccinations (Rabies, Parvo / Distemper / Bordatella).

Dogs with contagious conditions / illnesses are prohibited

Dogs must be at least four (4) months of age to enter park

Dogs in heat are not permitted in the park

### OWNERS:

Use of the park is at the dog owner's risk

Owner(s) must clean up after his/her dog(s) and dispose of waste appropriately, pursuant to Town of Abingdon Code (See Code Below) Owner is responsible for the actions of his/her dog(s) and shall repair/replace any damage (i.e., holes, etc)

Owners are strictly prohibited from leaving or abandoning any dog at any time A maximum of two (2) dogs per owner are allowed in the park at a time

Dog handlers must at least be 16 years of age

Children must be under direct supervision at all times and should not be admitted unless at least eight (8) years old

Animals other than dogs shall not be brought into the park

Owner must have leash on hand and be present inside the park with his/her dog(s) at all times while using park.

Dog(s) may be off leash ONLY within the fenced area of the park. Owner(s) are urged not to bring property into the park (dog toys, etc.) that cannot be used or shared with other dogs that might be utilizing the park

Dog owner(s) and/or handler(s) must wear shirts and shoes

### SITE AMENITIES:

On-site parking

One-acre park with five-foot (5') fence surrounding perimeter of park;

Double-gated transition area

Benches for dog owner(s)/ handler(s)

Doggie waste supply stations

Covered garbage/waste cans

Water fountain onsite for dogs and owners

### ARTICLE III. ANIMAL WASTE DISPOSAL

Sec. 10-51. Animal waste disposal. (a) Any person who is the owner, possessor or custodian of any animal shall promptly remove and dispose of all feces left by such animal on any public property or on any private property not owned and/or lawfully occupied by such person. (b) Any person violating the provisions of this section shall be guilty of a Class 4 misdemeanor. (Ord. of 2-5-07(2), § 10-30)
